# Are There Liability When You Apologise in Health Setting?

*An apology is the superglue of life! It can repair just about anything!! - Lynn Johnston*

Hong Kong's Apology Ordinance (Cap.631) (Ordinance) came into effect on 1<sup>st</sup> December 2017. The Ordinance is the first apology-protection legislation in Asia. The spirit of the Ordinance is to allow an apology to be made without fear that it will be used as evidence of admission of fault or liability in civil proceedings. The Ordinance has the scope to substantially changing the way insurance, evidence and settlements are approached in civil proceedings and regulatory and disciplinary matters. The seminar will focus on the advantages of the Ordinance and will draw to the audience attention of some of the areas one needs to be aware of when making an apology.

《道歉條例》(香港法例 631 章) 2017 年 12 月 1 日起生效，成為亞洲區首條就道歉受法律保障的條例。條例的精神允許任何人作出道歉時，無須恐懼在司法程序上構成承認過失的證據或責任。該條例涵蓋的範圍實質地轉變了保險、證據與和解的法律效力，以及在司法程序、規管及紀律事宜上所採取的方式。是次研討會將聚焦於條例的內容和影響，提升參加者在必須作出道歉時，應當如何處理。
